Terms and Conditions for Vector Energy Solutions' Solar promotion

Every person ("Customer") who signs a purchase agreement with Vector Energy Solutions Limited ("Vector") by 30th June 2017 to have Vector Solar installed will receive a free Blunt Umbrella, to be delivered when Vector receives the deposit specified in the purchase agreement (the "Promotion").

By signing a purchase agreement, the Customer is deemed to have read and accepted the following terms and conditions in relation to the Promotion. Signing a purchase agreement also confirms that the Customer has the necessary authority to do so.

- 1. To be eligible for the Promotion, a Customer must:
 - sign a purchase agreement in Vector's standard form ("Purchase Agreement") by 30th June 2017 agreeing to have Vector Solar installed at the customer's property;
 and
 - b. pay the deposit payable in accordance with the terms of the Purchase Agreement ("**Deposit**"),

("Eligible Customer").

- 3. Once Vector receives the Deposit, Vector will arrange for the delivery of that Customer's Blunt Umbrella to the address specified in the Purchase Agreement and will provide notification of this to the Customer.

Employees of Vector and its related companies, or members of the employee's families (including siblings, spouses, grandparents, parents, children, and grandchildren whether by marriage, past marriages, remarriage, adoption, co-habitation or other family extension) are not eligible for the Promotion.
- 5. Vector and its related companies shall not be liable for any loss or damage whatsoever suffered (including, but not limited to, indirect or consequential loss) or personal injury suffered or sustained in connection with the Promotion.
- 6. Vector reserves the right to vary, suspend or terminate the Promotion at any time.
- 7. Vector reserves the right to refuse to deliver a Blunt Umbrella in connection with the Promotion where there is a breach of any of these terms and conditions or where Vector considers (in its sole discretion) that a Customer has signed up for the Promotion using fraudulent or dishonest means.
